GOOD NEWS RECOGNITION/INFORMATION REPORT:

The Miami East-MVCTC FFA Chapter recently held its 60th Annual Parent Member Banquet. Over 300 parents, members, and guests were attendance at Miami East High School Gymnasium. Highlights of the evening were:

- In 2018, the chapter was ranked in the Top 10 out of 315 chapters in the state in the National Chapter Application. The chapter also placed in the Top 10 Chapter in the areas of Growing Leaders, Strengthening Agriculture, and Building Communities.
- At the 2018 National FFA Convention the chapter was recognized as a 3-Star National Chapter at the 2018 National FFA Convention. Additionally, the chapter was a Top 10 Chapter in the Nation in the area of Growing Leaders for our Little Library Program.
- Again in 2019, the chapter was named a Top 10 Chapter in the state and a Top 10 in all three areas of the National Chapter Application. The chapter will be interviewed at the 2019 State FFA Convention to be named the #1 chapter in the state.
