GOOD NEWS RECOGNITION/INORMATION REPORT:

We are very excited to announce that Miami East has partnered with FinalForms, an online forms and data management service, to simplify the back-to-school process for our families while reducing our paper usage. FinalForms allows parents to complete and sign enrollment, back-to-school, and athletic/club participation forms for your students.

The most exciting news is that FinalForms saves data from season-to-season and year-to-year, meaning that you will never need to enter the same information twice! FinalForms also pre-populates information wherever possible for each of your students, saving you time.

You may review your data at any time throughout the school year to verify it is current. You will be required to sign your forms once per year and after any update or as additional forms are added. For grades 6-12, some forms will require a student signature.

The District will begin the process of utilizing Final Forms in the Spring and then continue to offer other schools the opportunity to utilize this system through the Fall of 2021.
