Review of June 20, 2022 Regular Board Meeting

Mark Iiames, board president, called the regular meeting to order at 7:00 p.m., held in room 116 in the Lecture Hall at Miami East High School. The country was honored by the Pledge of Allegiance.

Roll Call was taken with board members John Demmitt, Amanda Howell, Mark Iiames, and Pam Rice in attendance.

PUBLIC COMMENTS: There were no public comments.

GOOD NEWS RECOGNITION/INFORMATIONAL

An ounce of prevention is worth a pound of cure. Proper and on-going preventative maintenance is essential to detecting and preventing structural, electrical, plumbing, and other problems across the district. As the name implies, preventative maintenance can help prevent more-costly repairs down the road. The summer is an excellent opportunity for the district to address numerous preventative items to ensure the safety and welfare of our students. Many of the projects are preventive upgrades, which similar to changing the oil in your vehicle saves the district from making more-costly repairs in the future.

Summer inspections are occurring across the campus in anticipation of the students and staff arriving in August. During the month of July items such as the bleachers, boilers, and buildings are inspected. Annual inspections and safety programs are a definite plan of action designed to prevent accidents. Although the District has reduced its Permanent Improvement Levy over the past few years, it continues to maximize this levy to make preventive maintenance for the District.

The district plans to continue making upgrades and getting prepared for the first day of school which will be here before you know it.

The Auditor of State has determined that he will not conduct the audit of the Miami County School District Pool for the period July 1, 2021 through June 30, 2022 (1 annual audit) and for the fiscal period July 1, 2022 through June 30, 2026 (2 biennial audits). An Independent Public Accountant's assistance in this auditing service is required.

The contract to audit the Miami County School District Pool has been awarded to BHM CPA Group, Inc.

The Total Fixed Fee Bid for Fiscal Years 2022 to 2026 is \$54,000.00.

2. The Southwestern Ohio Educational Purchasing Council released their 2023 Insurance Renewal Information. Miami East will have a 6% increase for both the PPO and HDHP Health Plan, and a 1.5% increase for the Dental Plan. The cost for the Vision Plan will remain the same.
