Review of August 17, 2020 Regular Board Meeting

Mark Iiames, board president, called the regular meeting to order at 7:00 p.m., held in room 116 in the Lecture Hall at Miami East High School. The country was honored by the Pledge of Allegiance.

INFORMATIONAL REPORT:

The District appreciates our students, staff, and parents' patience as we have prepared for the start of the school year as well. We will continue to re-evaluate based on evolving conditions, data about the status of the pandemic, and recommendations and guidance from public health authorities and the scientific community.

We understand that some students and/or members of their immediate family have health conditions that will not permit their participation in school. The option of online learning will be available for these families. Miami East will be prepared to help make sure that your child's learning needs are met.

If choosing at-home learning for your student(s), this will be a semester commitment. Information and an application are now posted on the Miami East website for the Online school option. Parents will have until August 17th to choose this option.
