Review of April 25, 2011 Regular Board Meeting

Mark Davis, board vice-president, called the regular meeting to order at 7:00 p.m., held in room 602 at Miami East Junior High School. The country was honored by the Pledge of Allegiance.

PUBLIC COMMENTS

Scott Clark attended the meeting and addressed the Board of Education. Mr. Clark distributed questions to the Board related to busing and asked Board members for additional information.

GOOD NEWS RECOGNITION:

- Reed Pyers and Morgan Decker, Miami East High School students, attended the Board Meeting to share their experiences from their recent New York City trip. Reed and Morgan shared photos of sites that the students visited including: China Town, the Empire State Building, and Ground Zero. Mr. Davis asked the students to describe the differences between Miami East and New York City. The students discussed the size of N.Y.C., traffic, and the speed in which everyone seemed to move. Mr. Accurso asked about their meals and both students responded that they enjoyed sampling different foods while on the trip.
- The Quandel Group updated the Board of Education on the status of the construction of the new high school. Mr. Schumaker reported the following during his report to the Board:
 - a. As soon as the rain eases up the sidewalks and pavement surrounding the building will be completed.
 - b. The gymnasium flooring installation has begun
 - c. The terrazzo tiling installation is continuing
 - d. The display cases in the hallways are nearly complete
 - e. The abatement of the high school food lab was completed over the Easter weekend and the K8 school was connected to the 18,000 gallon propane tank.

Mrs. Plummer then shared information about the abatement and demolition of the existing high school. These bids will be advertised this week. Bids for this portion of the project will be due on May 18th.
