Review of February 21, 2011 Regular Board Meeting

Rusty Miller, board president, called the regular meeting to order at 7:00 p.m., held in room 602 at Miami East Junior High School. The country was honored by the Pledge of Allegiance.

Roll Call was taken with board members Kevin Accurso, Brad Burton, Gayle Carson, Mark Davis, and Rusty Miller in attendance.

PUBLIC COMMENTS

GOOD NEWS RECOGNITION:

- Quandel updated the Board of Education on the status of the construction of the new high school. Mr. Schumaker reported:
 - The roofing is now 95% complete

 - Ceiling grids are being installed in the hallways and classrooms
 - First coat of paint has been applied to 80% of the building

- Staffing Reductions (English Teacher MEHS 2010-11)
- Administrative Reductions (Administrator 2009-10) reduced from 7 administrators across district in 2003 to 4 in 2010
- Reducing Permanent Improvements the next 5 years
- Freezing all new textbook purchases the next 2 years
- Freezing all library book purchases
- Freezing all computer and technology purchases
- Freezing all new bus purchase(s)
- Freezing all building budgets
- Freezing Treasurer Salary
- Freezing Superintendent Salary
- Freezing Professional Development
- Reducing Field Trips
- Froze all Supply Orders

2011-2012 Reductions

- Elimination of School Resource Officer Program
- \$110.00 Transportation Fee for all extra-curricular activities for students
- Delay All-day Everyday Kindergarten
- Elimination of Elementary Reading Intervention tutoring
- Elimination of all field trips
- Increased student fees
- 6-8 teachers reduced across the district
- 4-6 classified staff members reduced across the district
- As a result of staffing reductions electives and AP courses may be affected.
- Board of Education Self-Appraisal Process. Dr. Rappold inquired whether the Board would like to once again complete an annual self-evaluation. The Board agreed that they would like to complete this process once again and asked if Tom Dunn could be contacted to see if he would facilitate this process again this year.
- Board of Education annual tour of the campus and classrooms.
- School of Advertising Art (SAA) Letter. We would like to congratulate and recognize two former Miami East graduates, Ryan Harper and Caitlin Curtis. Both of these former Vikings were recipients of two American Graphic Design Awards. Of the thousands of entries from colleges across the country only 41 entries were selected to win this prestigious award. Congratulations to these graduating Vikings!
- Troy Kiwanis Club Teacher of the month for January 2011, Carmen Richters. Congratulations to Carmen Richters, who was named the January Kiwanis Teacher
