## MIAMI EAST LOCAL SCHOOLS BOARD BITS

Review of June 20, 2011 Regular Board Meeting

Rusty Miller, board president, called the regular meeting to order at 7:00 p.m., held in room 602 at Miami East Junior High School. The country was honored by the Pledge of Allegiance.

Roll Call was taken with board members Kevin Accurso, Gayle Carson, Mark Davis, and Rusty Miller in attendance.

Also in attendance were: Tom Dunn, ESC Superintendent; Kim Plummer, The Quandel Group; Dennis Schumaker, The Quandel Group; and Melanie Yingst, Troy Daily Newspaper.

## **PUBLIC COMMENTS**

There were no public comments heard.

#### **GOOD NEWS RECOGNITION**

Tom Dunn, ESC Superintendent, attended this evening's meeting to report to the Board of Education the results of the 2010-2011 Miami East Board of Education self-appraisals. The Miami East Board of Education annually completes a self-evaluation survey that ranks over fifty different items. Dr. Rappold credited the Board in completing this self-appraisal that then gives the Board areas to focus and improve upon during the upcoming school year. Mr. Dunn reported that the Board rated themselves as "effective" in well over 75% of the items surveyed. Several areas that were tallied the highest included working with the staff and communication.

One of the areas the Board would like to focus future attention is Board member professional development. Mr. Dunn offered to explore coordinating several Board only professional development offerings this year.

In addition, Mr. Dunn and the Board discussed the Treasurer job posting timeline and job description. The treasurer's position is currently posted for interested applicants. Mr. Dunn shared that eight candidates had already contacted the ESC to express an interest in the position. The ESC has offered to coordinate the job search on behalf of the Board for less than \$150. Mr. Dunn shared that when other professional organizations provide the same service to Boards of Education their costs are well over \$10,000. Board members tentatively discussed scheduling the first round of interviews during the month of July.

The Buehrer Group and Quandel Group presented to the Board of Education an update of the new high school project. Currently the high school project is 90% complete. Contractors are now working to resolve punch list items and several classroom floors that still need to be completed. The last bid for the project was accepted last week. Currently the project is \$1,469,957 under the estimated budget.
