# MIAMI EAST LOCAL SCHOOLS BOARD BITS

Review of October 17, 2011 Regular Board Meeting

Rusty Miller, board president, called the regular meeting to order at 7:00 p.m., held in room 116 in the Lecture Hall at Miami East High School. The country was honored by the Pledge of Allegiance.

# **PUBLIC COMMENTS**

There were no public comments heard.

#### **GOOD NEWS RECOGNITION:**

Mrs. Ashley Demmitt was in attendance to share information regarding the Miami County Park District's Nature Quest program for the 1<sup>st</sup> grade. Ashley that as a result of the generosity of the Miami County Park District every first grader has been given the opportunity to receive a free Nature Quest back pack. These back packs coincide with outdoor activities and reading opportunities. Students who complete these activities earn stickers that they can then turn in for various rewards. The program's goal is to encourage students not only to get outside, but to also read. Many of these activities encourage parent participation with their first graders. Activities are aligned with various first grade books that students check out while completing various activities.

Mr. Jeff Smith and Mr. Omar Lozano updated the Board of Education on the success of the district's music program. Mr. Smith shared with the Board that the district's instrumental program has been recognized for the following:

- The marching band competed and won the overall small bands competition in May at Cedar Point
- The marching band annually participates in the Troy Strawberry festival and Tipp Mum festival
- The marching band recently participated at Band Day at Miami University
- The concert band received a superior rating at OMEA District XI
- The concert band has had a consistent history of Excellent ratings at OMEA
- The jazz band annually performs at the senior citizens dinner

Mr. Lozano then updated the Board of Education on the success of the district's choir program. These recognitions have included:

- In 2010 the high school women's choir earned a Superior rating at OMEA
- At solo and ensemble the girls Ensemble 1 and Girls Ensemble 2 both earned Superior ratings
- The junior high honor choir consisting of 60 members earned a Superior rating in Class B
- The choir is active in the community performing at community events, athletic contests, and area nursing homes

Dr. Rappold recognized and thanked Mr. Cox and the Music Boosters for hosting a recent meeting with parents involved in the music program. This open forum discussed potential reductions in the music program if the levy is unsuccessful in November. The district would be forced to consider state minimums in electives including music. Dr. Rappold congratulated the district's music program for its success and the increase in participation in all three buildings. Dr. Rappold also shared that having spoken with districts that were forced to make the types of reductions Miami East would be forced to make it set their programs back ten years before they could re-establish the type of success Miami east has enjoyed over the past five years.
